Good afternoon Mr Stonnell,

I have sought advice on the technicalities and can confirm the Council's response to your question to Ms Dickinson is as follows:

We cannot accept this statement as an accurate summary. At the heart of your complaint was that the Executive report contained false information by making the statement:

'Once adopted the Local Plan will form part of the statutory Development Plan and will be used to determine planning applications. Until this happens the existing adopted plans will continue to set the planning framework.'

Your complaint was that 'The second sentence of this paragraph contains the false information because in a planning appeal decision made on the 21st August 2017 (See attachment APP/P0240/W/16/3166033) the planning inspector hearing the appeal concludes the Council's existing adopted plans are out of date and cannot be used to determine planning applications and planning appeals.'

We have set out in the formal response why we don't accept this as, firstly, the Inspector never made that statement in those terms and we have not seen any evidence from you that demonstrates the Inspector did and, secondly, that we have explained why the statement made in the Executive report is acceptable as far as we are concerned and is not false or misleading

The quashing of the Inspector's decision does not have a direct bearing on our starting position with regards the advice we gave to the Executive but in any event the decision was quashed and is, therefore, now immaterial.
